

# Privacy & Security Policy

StraxCorp respects your privacy and security. This statement informs you of our privacy and security practices and of the choices you are able to make about the way we collect your information online and how that information is used.

## **Sites covered by this Privacy and Security Statement**

StraxCorp Pty Ltd (ACN 140 706 618). This policy applies to all StraxCorp Pty Ltd owned websites and domains including all subsidiaries. In some circumstances a separate privacy policy may exist for some of our service web sites in specific jurisdictions. Please refer to the bottom of each web site for the privacy policy that governs those sites. Additionally, you may have a supplemental Agreement with us that will supersede this Privacy policy.

## **Links to third party websites**

As a convenience to you, we may provide links from our website to third party websites. If you access those links, you will leave our website or service. ## **Collection of personal information**

StraxCorp Pty Ltd only collects your information with your consent. We collect and use your personal information to serve you better, provide services and products and to better understand your needs and interests. For example, when you order products or services, request information, register or create an account on our website, subscribe to marketing or support materials, or participate in surveys or apply for a job with StraxCorp Pty Ltd, we will ask you to provide personal information to complete these transactions.

We may also collect information about your Internet Protocol (IP) address and which web pages you have visited. We may also collect information from emails that we send to you including when you opened the email and if you selected a specific link within the email.

## **We do not share your information**

StraxCorp Pty Ltd will not sell, rent or lease any marketing information we collect about you.

Except as described in this Statement, we will not share the personal information you provide to us with any third party without your permission unless:

- a) required to do so by law or to respond to a duly authorized request of the police or government authority.
- b) to help prevent fraud or to enforce or protect the rights and property of StraxCorp Pty Ltd.
- c) protect the personal safety of any member of staff or third parties on our property.

We do not knowingly collect information from children under 18 years of age. Children under 18 years of age are expressly prohibited from using our website and services.

### **Access to your information**

We require you to keep your personal information accurate while you use our website and services. We provide you with access to your information through our website and encourage you to maintain this information. Upon your request, we will in a timely manner delete your personal information stored within our website or store.

### **Site Security**

We use encryption technology when collecting or transferring sensitive information such as credit card information. Our service additionally uses hardware security and public private key technology to securely encrypt and store your information while it is in storage. This service gives you and us extra levels of security to guard against fraud and to protect your personal information.
